Minutes of the virtual meeting held on 19th April 2021 by Zoom on at 7.30pm.

Also in attendance: Lorna Thorne, Parish Clerk, and three members of the public.

• A Presentation was given by Lynda Sudlow from Airband on how they plan to deliver full fibre broadband to the two parishes. They plan to use existing infrastructure such as telegraph poles to run the fibre broadband into people's homes. It is hoped that the first phase in the area could be started in Q3 of this year with the second in Q1 of 2022 and completion early next year.

Dog Waste Bin (20/47.2)

Costings were received for a second litter bin to be installed at the playing field entrance. The cost of the bin would be $\pounds469$ +vat and $\pounds6$ a week to be emptied. This would be an ongoing cost of $\pounds312$ a year.

Cllrs agreed this was too expensive.

21/29 Financial

29.1 The Accounts Statement was noted by the Council.

29.2 Accounts Audit and Financial Year Report

The Parish Council Accounts for 2020/21 show a healthy balance.

The Parish Council originally had £25,000 in the Community Benefit Fund (CBF) and several requests of funds from local organisations have since been made. This year £2000 was spent on the Tolland Church Gate refurbishment. This fund now stands at £14756.02

During this financial year the Parish Council spent £570 of the CIL money to support the Outreach Post Office service to the Lydeard St Lawrence Village Hall. The Parish Council has also paid £200 for the 2019 Elections and £373.70 on new salt bins and salt for Westleigh area. The total in the CIL fund is now £1682.

The Footpaths grant from SW&TC of £300 was added to that fund which now stands at £2600. The annual grants from SW&TC were forwarded to the Churches and to the Cricket Club for the playing field and the Parish Council made Grants of £500 to the Village Hall Committee and Play Area.

At the end of the year the ring-fenced budget for the Play Area fund stood at £4500, with another £500 due to be added in April 2021.

The Council have £4229.30 in unrestricted reserves.

All other Parish Council expenses were in line with the Parish Council's budget for Clerk's Salary, Insurance, SALC affiliation fee, hall hire, newsletter and website.

29.3 Cllrs approved the Certificate of Exemption as the income and expenditure did not exceed £25,000

29.4 Cllrs agreed to approve the 2020/21 Audit Report Governance Statement

After much frustration, Cllr Marshall has been unable to get amendments made to the Bank Account to facilitate online banking. The only thing that can be done is to scrap the current account a get a new one. It was suggested that if Santander were so difficult to deal with then perhaps an alternative bank should be used. Currently banks are not taking on new customers during the pandemic, so it was suggested that the Parish Council continues as it is for the time being and review again in a few months' time.

URGENT! LYDEARD ST LAWRENCE PCC TREASURER WANTED

The PCC is most grateful to Don Hobson for the years he has given to looking after the finances of our village church. However, Don decided at the end of last year that he wished to step down and we have been trying to find someone to take on this position since then, without success.



We are therefore appealing to village residents - or to anyone not necessarily living in the village itself - to consider helping us out in this way.

It has been an honorary position, but because this is now becoming urgent the PCC is considering paying a small honorarium to anyone who feels that they might be able to assist us.

We already have an Independent Examiner of accounts. NEIGHBOURHOOD WATCH

30/03/2021 9788 Somerset: Buying & Selling on Social Media / Online Platforms. (Market Places)

We are seeing an increase in burglaries from garages and sheds where the offenders are clearly seeking out motorcycles, specifically dirt bikes such as KTM & Yamaha. It appears that a number of these bikes have been listed for sale on social media platforms, where a potential buyer arranges to view the vehicle but then doesn't turn up. Not surprisingly, a day or so later the Garage / Shed is broken into and an attempt is made to steal the bike or it is stolen.

If you are considering selling your vehicle - or any expensive item - follow the guidance provided on the website. Do not automatically assume it is safe to pass over your address details and or photos of your vehicle outside of your garage, especially if it shows your street name and garage number. If you do so and the purchaser doesn't turn up, be aware and pay close attention to the item you are selling and the security of the location it is stored.

Sadly, this may not just affect you. If your garage is broken into, your neighbour is likely to be targeted and may also sustain damage to their garage in the process.

Remember, whenever you place an advert you are also advertising what you have to steal. Read the guidance provided by the website carefully, and ask yourself if you really need to provide your address or do you meet somewhere public nearby? Always meet any prospective buyers in a well-lit, public area.

AIRBAND APRIL NEWSLETTER

Bringing Ultrafast Broadband

TO YOUR AREA

You may be aware that in December 2020, CDS (Connecting Devon and Somerset), with support from the Government, signed contracts with Airband to deliver full fibre broadband to 40,154 homes and businesses in earmarked areas of Devon and Somerset and require the construction of an estimated 2,419 miles of fibre network. Delivery will be in phases between 2021 and 2024.

As part of this new Fibre to the Premise (FTTP) Broadband network, Lydeard St. Lawrence and Tolland Parish has a number of premises within this contract that are to benefit directly. Many other premises along the fibre route and within close proximity may also be able to access the network once completed.

The section of the new network that will service your Parish is due to be completed in Quarter 1 and Quarter 2 2022 and surveying is imminent which will raise curiosity within your community. We intend to address this in advance where possible.

As the Community Liaison Executive for your region, I will be visiting your parish in the near future to engage with your community and give details of the technology, products and process that will be available for the project, and the benefits of full fibre broadband to your residential and business communities.

We are starting to develop our new Community Risk Management Plan (CRMP) which will run from April 2022 until 2027.

Historically there has been an Integrated Risk Management Plan and a Fire and Rescue Plan. The CRMP will replace these two plans with one document that outlines the risks in our communities and how we plan to manage those risks to make people safer.

Before developing the draft CRMP, we are gathering views from people and partners across Devon and Somerset. We are capturing this through <u>an online survey</u>.

As Chief Fire Officer Lee Howell says, "it would be helpful if you could arrange for this to be completed and shared as the higher number of contributions will give more insight to make sure we're aligning our future plans with the communities we serve."

The information we gather, alongside our incident data, will help us develop our CRMP. Once the draft plan is published, we will check that information has been accurately represented in the plan during a period of consultation. This will be towards the end of the year.
